



# ***Lobbyist Registration Statement***

Any person, business, corporation, association, firm, partnership, nonprofit organization or other organization or group required to register as a lobbyist shall register on this form and state ***under oath*** the lobbyist's name, residence address, business address, the full name and business address of each employer for whom lobbyist engages in lobbying activities, any direct business association lobbyist has with any current elected or appointed official or employee of the City of Lauderdale Lakes, and the general and specific subject matters which the lobbyist seeks to influence.

Any lobbyist representing a group, association, or organization shall, **prior to engaging in lobbying**, receive **appropriate authorization** with respect to said group, association, or organization to lobby on its behalf. A copy of the applicable minutes, motion or other documentation of action is **attached hereto**.

Registration is required for **each employer** for whom lobbyist engages in lobbying activities.

**Miscellaneous:**

1. Pursuant to Resolution # 05-08, an annual registration fee in the amount of \$100.00 shall be paid by all lobbyists at the time of registration with the City. Said fee shall also be due and payable October 1<sup>st</sup> of each subsequent year in which the lobbyist intends to engage in lobbying activities in the City of Lauderdale Lakes.
2. Lobbyists shall annually submit to the City Clerk's Office a signed statement, under oath, disclosing all lobbying expenditures, contingency fees, and the sources from which funds for making such expenditures and paying such contingency fees have come.
3. Any person engaged in lobbying activities shall be subject to investigation by the City Attorney, City Clerk, or their respective designees, for violations of the lobbyist registration Ordinances #05-03 and #05-07. Violations may result in censure and/or loss of lobbying privileges for up to two years by Commission action.
